Winter swimming

- **Action queried from April meeting:** “The request to extend winter swim hours is to be actioned”. Request was put in to extend the hours. MM update, no planned change. Full pool to run throughout this winter season.
- **Action:** MM & LW to review last year’s head count sheets for winter swimmers, before next committee meeting.

Memberships / Comments

- **Action:** MM/LW to ensure signs about membership are put up and staff are briefed about all the memberships options and all the 60+ options
- **Action:** Mark to ensure new Fusion website is updated with details of membership categories, showing discounts and concessionary rates available, including to 60+ users.
- **Action:** Reception staff to be informed about all these rates, including issuing cards to 60+ users, including swim only.
- **Action:** MM to investigate a shortcut to get to the comment/complaint/suggestion section on new website. This is to avoid people having to fill in lots of information before getting to their narrative comment.

Noise

- **Action:** LW to review approach to music being played on poolside, it has been raised that lots of people have personal music devices. MM to speak to LW to ensure that the control of these is enforced
- **Action:** LW to send BLU details of kid's camp in August. Details of pricing (who qualifies for concession in particular)
- **Action:** LW to speak to the resident who has complained about the noise and light pollution coming from the Luna film sessions. LW to confirm closing, 11pm should be closing time for the Luna cinema sessions. LW to speak directly to Luna about the volume of screening and the finishing times.
- **Action:** The Café to also be spoken to by LW about noise and closing time.

Pool lining

- **Action:** Preferred colour options for pool lining (blue) and lane lines (white) noted. White lane lines were agreed when pool last painted.
- **Action:** Quotes from other companies requested.
- **Action:** MP to find out who did the lining used in another large Lido (very big pool 91m x 33m)
- **Action:** Miranda and CJ to be involved in pool lining decisions

General

- **Action:** MM/LW to ensure that the whole pool is open at all times (exceptional circumstances aside)
- **Action:** continuous review of sun loungers to take place over summer. Monitor customer feedback. Decision to be made at the end of summer season BLU to also gather feedback.
- **Action:** MB to talk with LW re: table tennis hire of bats and balls
- **Action:** wall and floor to be looked at in the wet changing rooms. Poolside showers leaking, concern from committee this is effecting wall/foundations
- **Action:** locks on toilets keep being taken, site to review this
- **Action:** BI to update at next meeting re: raising the profile of BLSC and BLU
- New CCTV has been installed and camera angles/views reviewed and altered. **Action:** Fusion to give update at next meeting
